Florist of the Year Competition 2022

The terms and conditions are set out below, please read them carefully.

1. Entry to the competition will open at 12 noon on 1st November 2021 and will close at 12 noon GMT (UK time) on 31st January 2022.
2. Each schedule may be submitted individually between these dates.
3. This competition is open to florists and floral designers.
4. A competitor must be a permanent resident of the United Kingdom or Republic of Ireland. For the purposes of this competition, a person will be regarded as a permanent resident if they have their main home in the United Kingdom or Republic of Ireland, are registered with a medical practitioner in the United Kingdom or Republic of Ireland and hold a UK National Insurance number or Republic of Ireland Personal Public Services number.
5. Only one entry per schedule, per competitor.
6. All three schedules must be submitted by the closing date to qualify for judging.
7. All designs must be the original work of the competitor and be made solely by the competitor.
8. Images must NOT be manipulated or enhanced in any way.
9. The competitor must be the sole owner of the copyright of all images.
10. If using a photographer, it is the competitor's responsibility to ensure that image copyright has been assigned to the competitor.
11. All images are confidential and should NOT be shared before publication of the competition results.
12. Images previously used in another competition may NOT be submitted.
13. Images must state the full date created.
14. If floral foam is used, ONLY biodegradable floral foam may be used.
15. Images must be submitted via the official competition platform. Images sent in any other way will NOT be accepted.
16. All images must be put in a file by the competitor, [one file per schedule clearly labelled with entry number and schedule number] named by the competitor and sent via WE TRANSFER to the Floristry Judges Guild email address.
17. All competitors must state their full name, home address, business address and email address, mobile number, and professional social media account names on the entry form.
18. Full payment of the entry fee (£15 per competitor) must be made at the time of entry.
19. You must provide **the correct number of images** for your entry as specified within the schedules.
20. Images must be in high resolution and each image a minimum file size of 2mb.
21. Images must be sent as a JPEG or PNG.
22. All designs must be photographed as specified within the schedule.
23. Lifestyle/location images will **NOT** be judged.
24. This competition is the sole ownership of Interflora.

25. Images remain the property of the competitor, but by entering the competition, permission is granted for Interflora and the UK Floristry Judges Guild to use the images in publicity.
26. The semi-finalists will be notified by 28th February 2022. These semi-finalists will be expected to progress and compete at the live semi-finals in April 2022. The successful competitors from the semi-finals will progress to a live final in July 2022.
27. Certificates of participation will be awarded to all competitors, which may be used for CPD purposes.
28. Competitor personal data will be collected by the UK Floristry Judges Guild on behalf of Interflora British Unit. By entering this competition, you consent to Interflora British Unit sharing your personal data with the UK Floristry Judges Guild. We shall ensure that we comply with the requirement of all applicable data protection, privacy and consumer legislation including, without limitation, the Data Protection Act 2018, the General Data Protection Regulation (EU) 2016/679 and other applicable data protection legislations (as replaced, modified, or re-enacted from time to time). We shall only use or share personal data received from you for the purpose of fulfilling our obligations in connection with this competition and as stated in the Interflora Privacy Policy.
29. The judge's decision is final, and no correspondence will be entered into.

Don't forget your entry will NOT be valid if you haven't completed an entry form AND made full payment.
